All entry fees should be forwarded to our Show Secretary prior to closing date

No post dated cheques accepted. All NSF cheques will be Subject to a charge of \$20.00.

N.S.F. cheques are considered non-payment of entry fees and are punishable by disciplinary action and cancellation of awards. All fees must be paid before the show.

Important Note Regarding Emails & Faxes

It will be the responsibility of the exhibitor to ensure that any electronic submission, either email, facsimile, or any document transmitted electronically, reaches the proper authority or recipient, within the times and limits as regulated for each document in the CKC Rules & regulations. Sent fax receipts, and/or, copies of sent emails, will not be taken as evidence of receipt by recipients

Attention USA exhibitors: Please note that

fees are due and payable in Canadian dollars. Due to consistently fluctuating currency rates, discounted cheques will not be accepted. Personal cheques will be accepted, however, they are to be payable in Canadian funds. If you send a cheque in US funds, it must be made out for the full amount of the entry and no exchange will be refunded to the exhibitor.

Please do not mark cheques "Payable in Canadian Funds" or "At Par". They will not be cleared by the banks. To simplify the process, we urge that you purchase bank drafts or money orders payable in Canadian funds. Your understanding and cooperation is appreciated. Thank you

ENTRY INFORMATION

1. No entry will be accepted unless accompanied by proper entry fees and forms.
2. Incomplete entries will be returned.
3. Telephone and telegraph entries are prohibited under CKC rules.
4. Exhibitors must abide by errors made in entering their dogs regardless of how or by whom entries were made.
5. Changes, cancellations, or substitutions after Closing Date are prohibited.
6. Only dogs eligible for CKC registration may enter this trial. The Committee reserves the right to refuse any entry subject to CKC rules.

ELIGIBILITY

In order to be eligible to compete in these trials, a dog must be registered with the CKC, hold an ERN, PEN, or Misc. number, or be eligible for same. Dogs may be spayed, neutered and/or debarked. Dogs must be 18 months of age or older. Dog may not compete if it has tape or bandages (such a dog must be immediately excused and may not return later for judging after same has been removed.) Dog may not be lame.

BITCHES IN SEASON are not permitted to compete. When a bitch comes into season after the entry has been submitted to the Trial Secretary and a Veterinarian's certificate that the bitch was in season within the 10 day period preceding the trial is presented to the secretary on or before the start of the trial, the trial giving club will refund all entry and listing fees.

CONTACT FAMILIARIZATION will not be available at these trials.

SURFACE Trial will be run outdoors on sand/gravel

PRECINCTS The precincts of the trial will extend to 20 ft. beyond the ring.

VOLUNTEERS Volunteers are needed to help with timing and scribing. If you are willing to volunteer, please indicate your preference and include with your entry.

MOVE-UPS will be allowed from the morning trial to the afternoon trial and must be completed at least one hour prior to the start of the afternoon trial.

RIBBONS: Flat ribbons will be offered in each jump height in each class for all qualifying scores.

GENERAL INFORMATION

- The Trial Superintendent will be in full charge of the trials
- Judging schedules will be mailed as soon as possible after the Closing Date.
- If because of riot, civil disturbance, or other acts beyond the control of the management, it is impossible to open or to complete the show, no refund of entry fees will be made.
- It shall be the duty and obligation of the show-giving club to see that a judge, club official, volunteer, or any participant at an event held under these rules is not subject to indignities of any kind. The Agility Trial Chair shall promptly report to the CKC any infringement of this regulation, and the Discipline Committee shall have the authority to take such action as it deems fit on receipt of a report indicating that this has occurred.

Event Registration Number (ERN)

All dogs that are foreign born and foreign owned and enter Canada for the sole purpose of entering CKC events will require an Events Registration Number (ERN)

To obtain an ERN number simply do the following:

1. Send a photocopy of the dog's registration certificate reflecting current ownership, for example AKC Registration Certificate with a written request for an ERN number.
2. Include with the above a cheque or money order in the amount currently required payable to the Canadian Kennel Club.
3. Ensure that you provide us with your full return address to enable the ERN number to be sent to you.
4. Faxed requests will be accepted. Please indicate your Visa/MasterCard number expiry date, cardholders name and signature.

This Event Registration Number MUST be applied for within 30 days of the first day of entering a CKC event. Dogs may be entered as "LISTED", however, failure to apply for an ERN number within 30 days will result in cancellation of any wins, awards or scores.

Directions to the agility trial.

From Halifax International Airport:

HWY-102 S via the ramp to **Halifax/Dartmouth**

Take the exit on the **left** onto **HWY-118 S** toward **Halifax/HWY-111/HWY-103/Dartmouth**

Take exit **13W** to merge onto **Akerley Blvd/HWY-107 W** toward **Akerley Blvd/Burnside Ind. Park**

Continue to follow Akerley Blvd Turn **left** at **Joseph Zatzman Dr.**

From Halifax:

Take the **MacKay Bridge to Dartmouth**, merge onto **HWY-111 N**

Take exit **3** for **Burnside Industrial Park** toward **Highfield Park Dr.**, turn **left** at **Burnside Dr/Highfield Park Dr.**

Continue to follow Burnside Dr., turn **left** at **Wright Ave**, and Turn **right** at **Joseph Zatzman Dr.**
